#### **Adoption of the Agenda for the meeting minutes**

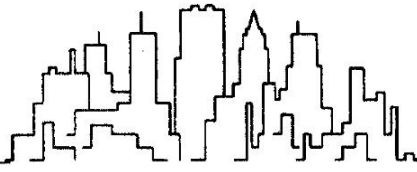
- Sheroy Haveliwala adopted the agenda for this meeting and was seconded by Khushrav Nariman.
